### MODE OF MEETING

The 63<sup>rd</sup> Annual General Meeting (“63<sup>rd</sup> AGM”) of the Company will be conducted on a virtual basis using online remote voting via Remote Participation and Voting (“RPV”) facilities. This is in line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia (including any amendment that may be made from time to time).

### REMOTE PARTICIPATION AND VOTING FACILITIES (“RPV”)

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, “participate”) remotely at the 63<sup>rd</sup> AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. (“Tricor”) via its TIIH Online website at <https://tiih.online>. Please refer to Procedure for RPV.

A shareholder who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 63<sup>rd</sup> AGM via RPV must request his/her proxy(ies) or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at <https://tiih.online>. Please refer to Procedure for RPV.

As the 63<sup>rd</sup> AGM is a fully virtual 63<sup>rd</sup> AGM, shareholders who are unable to participate in this 63<sup>rd</sup> AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

### PROCEDURES FOR RPV

Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) who wish to participate the 63<sup>rd</sup> AGM remotely using the RPV are to follow the requirements and procedures as summarized below:

#### BEFORE THE 63<sup>rd</sup> AGM DAY

##### Register as a user with TIIH Online

- Using your computer, access the website at <https://tiih.online>. Register as a user under the “e-Services”. Refer to the tutorial guide posted on the homepage for assistance.
- Registration as a user will be approved within one working day and you will be notified via email.
- If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.

##### Submit your registration for RPV

- Registration is open from Monday, 31 July 2024 until the day of 63<sup>rd</sup> AGM on Friday, 27 September 2024. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 63<sup>rd</sup> AGM to ascertain their eligibility to participate the 63<sup>rd</sup> AGM using the RPV.

- Login with your user ID and password and select the corporate event: **“(REGISTRATION) SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM”**
- Read and agree to the Terms & Conditions and confirm the Declaration.
- Select “Register for Remote Participation and Voting”.
- Review your registration and proceed to register.
- System will send an e-mail to notify that your registration for remote participation is received and will be verified.
- After verification of your registration against the General Meeting Record of Depositors dated 20 September 2024, the system will send you an e-mail after 25 September 2024 approve your registration for remote participation and the procedures to use the RPV are detailed therein. In the event your registration is not approved, you will also be notified via email.

*(Note: Please ensure to allow sufficient time required for the approval as a new user of TIIH Online as well as the registration for RPV in order that you can login to TIIH Online and participate the 63<sup>rd</sup> AGM remotely).*

## ON THE DAY OF THE 63<sup>rd</sup> AGM

### Login to TIH Online

- Login with your user ID and password for remote participation at the 63<sup>rd</sup> AGM at any time from 8.00 a.m. i.e. 1 hour before the commencement of the 63<sup>rd</sup> AGM on Friday, 27 September 2024 at 9.00 a.m.

### Participate through Live Streaming

- Select the corporate event: **“(LIVE STREAM MEETING) SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM”** to engage in the proceedings of the 63<sup>rd</sup> AGM remotely.
- If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by you during the 63<sup>rd</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.

### Online Remote Voting

- Voting session commences from 9.00 a.m. on Friday, 27 September 2024 until a time when the Chairman announces the end of the session. Select the corporate event: **“(REMOTE VOTING) SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM”** or if you are on the live stream meeting page, you can select **“GO TO REMOTE VOTING PAGE”** button below the Query Box.
- Read and agree to the Terms & Conditions and confirm the Declaration.
- Select the CDS account that represents your shareholdings.
- Indicate your votes for the resolutions that are tabled for voting.
- Confirm and submit your votes.

### End of remote participation

- Upon the announcement by the Chairman on the closure of the 63<sup>rd</sup> AGM, the live streaming will end.

### Note to users of the RPV facilities:

1. Should your registration for RPV be approved we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIH Online on the day of meeting will indicate your presence at the virtual meeting.
2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

### APPOINTMENT OF PROXY OR ATTORNEY OR CORPORATE REPRESENTATIVE

Shareholders who appoint proxy(ies) to participate via RPV at 63<sup>rd</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Wednesday, 25 September 2024 at 9.00 a.m.**

The appointment of a proxy may be made in a hard copy form or by electronic means in the following manner:

(i) In hard copy form

In the case of an appointment made in hard copy form, the proxy form must be deposited with the Company's Share Registrar at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or alternatively, the Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia.

(ii) By electronic form

The proxy form can be electronically lodged with the Share Registrar of the Company via TIH Online at <https://tih.online>. Kindly refer to the Procedure for Electronic Submission of Proxy Form.

Please ensure ALL the particulars as required in the proxy form are completed, signed and dated accordingly.

## ADMINISTRATIVE GUIDE

Any authority pursuant to which such an appointment is made by a power of attorney must be deposited with the Share Registrar of the Company at Tricor Investor & Issuing House Services Sdn. Bhd., Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or the Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia not later than **Wednesday, 25 September 2024 at 9.00 a.m.** to participate via RPV in the 63<sup>rd</sup> AGM. A copy of the power of attorney may be accepted provided that it is certified notarially and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

For a corporate member who has appointed a representative, please deposit the **ORIGINAL** certificate of appointment with Share Registrar of the Company at Tricor Investor & Issuing House Services Sdn. Bhd., Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi,

59200 Kuala Lumpur, Malaysia or the Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia to participate via RPV in 63<sup>rd</sup> AGM. The certificate of appointment should be executed in the following manner:

- (i) If the corporate member has a common seal, the certificate of appointment should be executed under seal in accordance with the constitution of the corporate member.
- (ii) If the corporate member does not have a common seal, the certificate of appointment should be affixed with the rubber stamp of the corporate member (if any) and executed by:
  - (a) at least two (2) authorised officers, of whom one shall be a director; or
  - (b) any director and/or authorised officers in accordance with the laws of the country under which the corporate member is incorporated.

### PROCEDURES FOR ELECTRONIC SUBMISSION OF PROXY FORM

The procedures to submit your proxy form electronically via Tricor's **TIIH Online** website are summarised below:-

#### Steps for Individual Shareholder

##### Register as a User with TIIH Online

- Using your computer, please access the website at <https://tiih.online>. Register as a user under the "e-Services" by selecting **"Create Account by Individual Holder"**. Please do refer to the tutorial guide posted on the homepage for assistance.
- If you are already a user with TIIH Online, you are not required to register again.

##### Proceed with submission of Form of Proxy

- After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password.
- Select the corporate event: **"SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM - SUBMISSION OF PROXY FORM"**.
- Read and agree to the Terms & Conditions and confirm the Declaration.
- Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf.
- Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint Chairman as your proxy.
- Indicate your voting instructions – FOR or AGAINST, otherwise your proxy(ies) will decide your vote.
- Review and confirm your proxy(ies) appointment.
- Print proxy form for your record.

## Steps for Corporation or Institutional Shareholders

### Register as a User with TIIH Online

- Access TIIH Online at <https://tiih.online>.
- Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects **“Create Account by Representative of Corporate Holder”**.
- Complete the registration form and upload the required documents.
- Registration will be verified, and you will be notified by email within one (1) to two (2) working days.
- Proceed to activate your account with the temporary password given in the email and re-set your own password.

Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact the persons stated under **“ENQUIRY”** section below if you need clarifications on the user registration.

### Proceed with submission of Form of Proxy

- Login to TIIH Online at <https://tiih.online>.
- Select the corporate event: **“SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM - SUBMISSION OF PROXY FORM”**
- Read and agree to the Terms & Conditions and confirm the Declaration.
- Proceed to download the file format for **“SUBMISSION OF PROXY FORM”** in accordance with the Guidance Note set therein.
- Prepare the file for the appointment of proxy(ies) by inserting the required data.
- Submit the proxy appointment file.
- Login to TIIH Online, select corporate event: **“SELANGOR DREDGING BERHAD 63<sup>rd</sup> AGM – SUBMISSION OF PROXY FORM”**.
- Proceed to upload the duly completed proxy appointment file.
- Select **“Submit”** to complete your submission.
- Print the confirmation report of your submission for your record.

### POLL VOTING

The voting at the 63<sup>rd</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Shareholders or proxy(es) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions at any time from **Friday, 27 September 2024 at 9.00 a.m.** but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to Procedures for RPV for guidance on how to vote remotely from TIIH Online website at <https://tiih.online>.

Upon completion of the voting session for the 63<sup>rd</sup> AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

### PRE-MEETING SUBMISSION OF QUESTION TO THE BOARD OF DIRECTORS

Shareholders may submit questions for the Board in advance of the 63<sup>rd</sup> AGM via Tricor's TIIH Online website at <https://tiih.online>

by selecting “e-Services” to login, pose questions and submit electronically no later than **Wednesday, 25 September 2024 at 9.00 a.m.** The Board will endeavor to answer the questions received at the 63<sup>rd</sup> AGM.

### DOOR GIFT/FOOD VOUCHER

There will be no door gifts or food vouchers for attending the 63<sup>rd</sup> AGM.

### NO RECORDING OR PHOTOGRAPHY

Unauthorized recording and photography are strictly prohibited at the 63<sup>rd</sup> AGM.
